## **SOMETHING IS FISHY HERE !!**



**THAT WASN'T  
FUNNY!**

### **THE BOARD IS AGGRESSIVELY REPAIRING VANDALIZED, ABUSED, AND WORN ITEMS IN THE GROVE!**

About a month ago, the life guards discovered 16 dead fish in the pool. They were 6 to 8 inches long. They were not thrown over the fence. At the steps at the corner of the pool closest to the wading pool there was dirt and debris on the steps which indicates that someone climbed over the fence to dump the fish in the pool. There was a considerable amount of work required by the life guards to remove the fish, clean the pool and bring the pool chemistry back to acceptable levels. All of this caused the pool to open later than normal.

The gazebos are currently being completely overhauled. The gazebo at the pond requires the most extensive repair. The top railings are being replaced because the old railings had been carved and defaced extensively. One of the benches had to have extensive repair work done. There were only two benches remaining at the time the work started, therefore we are having three new benches built and installed. The lattice work at the base of the gazebo is being repaired or replaced. No one should climb over the railing and walk in the water or attempt to remove the lattice. Both gazebos have been power washed, sanded and scraped, primed, painted and the weather vane at the top of each removed, refinished and solidly installed.

The door handle and lock on the men's restroom at the club house has been replaced. The tables at the club house which had legs which looked like they were about to fall off the tables have now been repaired by gluing them to the table and additional screws installed.

Quotes have been received to remove all dead trees in the common areas. This work will start shortly and will take approximately a week to complete.

There are some dead shrubs at both entrances. Current plans are to remove them this fall and install new plants.

The board plans to plant some additional trees in the common area this fall.

One of the signs which cautions drivers to slow down as they approach the club house and the cross walk have been vandalized twice within the past month. The first time the sign was on the ground at the base of the post. This is a strongly built sign. It appears to have been struck with considerable force which broke off the top inch of the sign which left the screw and the top inch still on the post. The sign was repaired and reinstalled to the post. The second time someone unscrewed the sign and took the sign. Currently, contact is being made to a sign company to have this replaced.

The Cold War Museum is an affiliate with the Smithsonian Institution. As a result, it has pledges of support for artifact loans from Smithsonian Air and Space, American History, National Portrait, and US Postal Museums. The Museum is working with the Spy Museum in Washington, DC to temporarily display artifacts. But, the work has just begun and they need to continue fundraising efforts in order to build The Cold War Museum and Memorial.

The mobile exhibit on the U-2 Incident, the “Spies of Washington Tour,” and book signing lectures continue to generate interest and support. The mobile exhibit is currently on display at the Southwest Virginia Museum in Big Stone Gap, Virginia through October 10, 2006. The educational “Spies of Washington Tour” ([www.spytour.com](http://www.spytour.com)) now includes an optional stop at the International Spy Museum in Washington, DC. The Cold War Museum is also in negotiations with the National Archives to produce a Cold War lecture series in the near future.



October 13-15, they are planning a groundbreaking ceremony in conjunction with a conference on the 1956 Hungarian and Polish Crises. Sergei Khrushchev, the son of Nikita Khrushchev, Mr. Laszlo Rajk, the son of an executed Communist leader of Hungary, and a representative from the Polish Embassy will be participating. In addition, there will be a book signing and a panel comprised of Nike Missile veterans that will discuss the history of the Nike missile program with specific insight into Lorton site history.



They are at a critical stage of development. Fairfax County Park Authority is reviewing the second phase proposal to locate at the former Nike Missile Base in Lorton, Virginia and negotiations are underway to occupy the site as early as this fall.



The museum continues its involvement with the Combined Federal Campaign, which allows Federal government and military employees to donate to the Museum directly through payroll deduction.

## Chesterfield County's Seal

Although English colonists began moving into the area within four years of Jamestown's founding in 1607, Chesterfield was not created as a political unit until 1749. Formed from the southern half of Henrico County, one of Virginia's several original shires, the new county took the name of the celebrated literateur and politician Philip Dormer Stanhope, Fourth Earl of Chesterfield.



In 1870, the first action of the first Chesterfield County Board of Supervisors was to direct a seal to be created, "to wit: a coal miner leaning on his pick under a pine tree with a flowing river at his feet." This was chosen as the County's Seal because it was the first place in the nation where coal was mined commercially.

As a result of the industrious labors of miners, other "firsts" occurred in Chesterfield: Midlothian Turnpike, the first paved road in Virginia, was built in 1807 to carry carts of coal; and in 1831, the first railroad, the Midlothian to Manchester Railroad, was built to haul coal to Virginia's ports.

Chesterfield straddles two major topographic regions. Most of the county lies in the Piedmont, a region of gently rolling hills stretching between the Appalachian Mountains and the Atlantic coastal plain. The pine tree on the seal represents the timber associated with the rolling hills of the area.

Although Chesterfield is laced by streams, most are too narrow or shallow to use as waterways. The James and Appomattox Rivers, though, served as major commercial corridors from the first period of European settlement. Thus, the river depicted on the seal.

## **America's 400<sup>th</sup> Anniversary In Jamestown**

In 2006 and 2007, America will commemorate an event that changed the world — the settling of Jamestown, Virginia in 1607. The first permanent English settlement in North America, Jamestown established the culture that would flourish and leave the legacies of free enterprise, representative government and cultural diversity to our nation.

Americans have observed Jamestown anniversaries every 50 years in a spectacular manner. The 1907 Jamestown Ter-Centennial Exposition drew 1.5 million visitors to Norfolk and featured speeches by President Theodore Roosevelt, Booker T. Washington and Mark Twain. In 1957 more than a million visitors came to Virginia as America's 350<sup>th</sup> anniversary focused on historical preservation and education. Perhaps the most memorable moment, however, came when Queen Elizabeth II addressed thousands of people at Jamestown during her first official trip to the U.S. as monarch.

Jamestown 2007, an agency of the Commonwealth of Virginia, is working with local, state, and national groups to stage a memorable commemoration of America's 400<sup>th</sup> Anniversary. Jamestown 2007 is developing an 18-month series of national and international Signature Events to commemorate various aspects of the Jamestown story.

The Premier Signature Event will be **America's Anniversary Weekend**, a three-day spectacular event centered at the Jamestown sites on **May 11 – 13, 2007**. The President and First Lady, Queen Elizabeth II and other members of the Royal Family will be invited to participate in this landmark event, which will feature pageantry, musical performances, cultural presentations and celebrity appearances.
