New Grove HOA Policy Concerning Portable Temporary Storage Units

The Board at the June HOA meeting approved the following addition to the Grove HOA covenants governing the use of portable temporary storage units:

Portable temporary storage units, such as PODs, Smart Boxes, or other similar containers for the storage of personal property will be permitted under the following conditions:

1. The temporary storage unit will be allowed within the community for 7 (seven) days.
2. Temporary storage units may only be placed in a resident's driveway. Only 1 storage unit per home will be permitted.
3. Homeowner is responsible for the cost and repair of any damage caused by the placement, storage and/or removal of such a unit to any common property and areas, which includes parking lots and/or homeowner property.
4. Homeowner is responsible for providing prior written notice to the Board of Directors via the management company by supplying the dates of the use of the storage unit.
5. The length of time needed for the portable storage unit may be extended through communication with the management company. Additional time may be granted for extenuating circumstances. The Board of Directors reserves the right to grant additional time as determined on a case-by-case basis.

On May 12, 2010 the Grove Homeowners Association held a special meeting for members to vote on the proposed bylaws amendment increasing term limits for Board of Directors from one year to two years. The required number of proxies to approve the amendment was not received; therefore the meeting will stay in recess until the majority of homeowners turn in their proxies.

Increasing the term of service for Board of Directors from one to two years allows them to gain momentum in office and concentrate on long-range goals for our neighborhood. Fewer turnovers on **the Board means there's more focus on the job at hand, instead of wasting time transitioning in and out of office.**

Architectural Review

A reminder that the planting and removal of trees requires approval!

ARTICLE VII - ENVIRONMENTAL COVENANTS: In order to protect the natural beauty of the vegetation, topography or other natural features within the Subdivision, the following environmental controls are hereby established.

7.01. Trees. To the extent reasonably practical, the clearing of mature trees on Lots shall be limited to those areas required to accommodate the residence to be constructed thereon and its normal and customary accessories, open front yard areas and those areas required to permit utility services and driveways. No trees measuring six (6) inches in diameter at a point two (2) feet above ground level which are located more than twenty (20) feet away from the residence or structure constructed on the Lot, shall be removed without the prior written approval of the Architectural Control Committee.

Some other things that need ARC approval are: changing paint colors, additions, sheds, play equipment, swing sets, decks, landscaping changes, irrigation, new driveways and sidewalks, etc. Basically anything you do to alter the outside of your home including anything on your property.

HOW THE ARCHITECTURAL REVIEW PROCESS WORKS

In an effort to streamline the exterior modification application process, the Modifications Committee is now using a new web-based service to review modification requests. Requests are now loaded onto the web-based program, where committee members and the HOA board may review, discuss and decide on applications as they are received. Owners are then notified of decisions via email, so please be sure to include your email address on your application. This new system also provides for better record-keeping of approved requests.

Clubhouse Rental Policy

When reserving the clubhouse it is required that set up and clean up time be factored into the requested rental time period. The clubhouse key is made available approximately 1/2 hour prior to rental start time and is not issued earlier for residents to access the clubhouse for set up. If a key is requested earlier than the rental start time per the signed agreement the additional fee for this time period must be paid at the time of key pick up.

County to Start Charging Recycling Fee

As of July 1, an annual fee of \$25 will be applied to each household to support this program. This fee will be included on the county's real estate tax bill, with \$12.50 charged in December and the other \$12.50 charged in June each year. Homes not currently on curbside recycling routes will be added to the schedule on or about **July 1, 2010**. If you would like to participate in the recycling program and have not received a bin, please contact CVWMA at 340-0900, to request a bin or

recycling sticker for containers you own. Residents wanting to opt out must do so by **Sept. 15** to avoid the first charge on their real estate tax bills. There are two ways residents may opt-out of the program. The first option is to call our Customer Service Center at **804-748-1297**. August Sales Tax Holiday: School Supplies and Clothing

When: First full weekend of August (Friday, Saturday and Sunday) each year. The 2010 holiday will take place on August 6-8, 2010.

What's Exempt: During this three-day period, purchases of qualifying school supplies selling for \$20 or less per item, and purchases of

qualifying clothing and footwear selling for \$100 or less per item will be exempt from sales tax. Retailers may also choose to absorb the tax on other items during the holiday period, but they are responsible for paying the tax on those items to the Department of Taxation.

Families who are ready recover faster

Although meteorologists can't predict exactly how tropical systems and hurricanes will affect Virginia this year, there is one prediction that will come true: *families who are ready will recover much better and faster than those who are not.*

Everyone should be prepared to be self-sufficient for at least the first 72 hours after a storm hits. Every home should have at least four basic items:

- A family emergency plan
- Three days' of bottled water (one gallon per person per day)
- Three days' of non-perishable food

A hand-crank or battery-powered radio with extra batteries for listening to emergency information from local media and officials

Store these items in waterproof containers that have wheels or that you can lift easily in case you have to leave.

Second Water Meters Save Money

Interested in reducing your water bill? Consider adding a second water meter, or residential companion meter, to your irrigation system. With one meter, water and sewer charges are combined, such that every time you water your lawn, the sewage portion of your bill increases. A second meter will measure outside water usage separately eliminating any additional sewage charges associated with irrigation.

To get a second water meter you must apply for a county plumbing permit for residential companion meter for irrigation service, which also covers backflow device installation, from the Building inspection department. To contact them call 748-1057. You must also apply for a water

connection from the new Construction Department at 748-1862.

The residential companion meter can be bought from Chesterfield County Utilities for \$420, and reduces energy costs over time. It is only for Chesterfield County residences not commercial properties.

Som Patasomcit: Thirty Years of Freedom

Every day is Independence Day for Grove Resident **Som Patasomcit**, as he proclaims, **“thirty years of freedom, in the land of the free.”** Wearing nothing more than a shirt and pair of shorts, he and his Dad escaped Communist oppression and death threats, crossing countries and cultures on a long, hard journey to liberty.

As a child, before the soldiers in green uniforms arrived, nine year old Som thought life was good. He attended school, and played with friends. After school, he went to the home of his beloved **grandmother (father’s mother) until his father got off work.** Then Som and his Dad would go to their own house. They lived in Dong Pai Nha, Laotian for **“rice field village”, near the Vientiane province and capital.** Som compares his village to Smithfield or Farmville in their proximity to Richmond. The people of Dong Pai Nha were poor, yet self-sufficient and close-knit, with rural roots and values. They farmed and ran small businesses. Most owned homes. There was no indoor plumbing, only well-water. Having no electricity, they used oil lamps. There were no cars to traverse dirt roads; villagers **either walked, rode bikes, or mopeds.** **“But,” Som shrugs, “everyone lived that way.”** Life was good, until the Communists took over.

One day, while Som played in the streets with his

friends, the Communist soldiers invaded Dong Pai Nha. At gunpoint they took the foreign compound **adjoining the village.** **Som’s fright turned to gratitude** that no one died. Then, the soldiers commanded the village leaders to take all residents to the compound, where they saw a film describing and **applauding the overthrow.** **Som stated, “The film said, we have a new boss, and flashed a picture of the leader in Communist China. We had a new flag, new currency, and new government.”** Shortly afterward, the new regime controlled all businesses, especially profitable ones. Free enterprise was gone. Soon, the Communists imprisoned those Laotians in intelligent professions such as teachers and policemen, because they perceived professionals as negatively influenced by foreigners (Americans). Anyone who worked or talked with foreigners was **arrested and jailed in “re-education camps.”** According to Som, some survived, others did not. **That’s when Laotians began to flee the country.**

Communist threats against foreign influence hit home. One night, while Som was sleeping, they took away his mother. Som would not see her for ten years. **Although Som’s Dad now worked for the Communist Government,** seeds of doubt grew against him. The regime discovered his Dad had

served in the Laotian army, and suspected collusion with Americans. One night, he did not come home from work. Unknown to Som, Communist coworkers warned his Dad of the impending arrest, so he went into hiding.

A day later, while Som was outside with friends, a woman, a stranger, on bicycle approached him,

stating she was taking him to his Dad, who was alive but in hiding. Som was frightened, refusing to go. Finally she persuaded him to trust her, and she **brought him to his uncle's home. Terrified they'd be caught**, Som and his Dad rode a taxi, to the Mekong River. The boatmen knew border patrol movements and times to cross safely, but Som and his Dad still feared getting shot to death. It was a long, **harrowing crossing. Water rolled over the canoe's top as it rocked sideways.** Som grabbed its sides, fearing rumors of large eels that would eat him if he fell out.

At the Nhong Kai Refugee camp, Som and his Dad felt safe, but conditions were insufferable. There was **no privacy. Each family lived in tiny 5'x10' areas**, partitioned by strands of thin, bamboo straws. With putrid food, and limited access to water, illness pervaded camp. But they survived it all, forming friendships, and starting a small business. There was no school for refugees, so Som mastered soccer. Som and his Dad could have immigrated with several European sponsors, but endured 2 years to go to America. Then they took a long bus ride to Bangkok, without food or water. But they were happy to be USA bound.

Marilyn Breslow of Refugee and Immigration Services helped Som and his Dad learn American life **and language. They were Marilyn's first resettlement.** Along with volunteers Roy and Anne Garrett, Marilyn assisted with green cards, housing, furniture, **clothing, and a job for Som's Dad. They shopped at stores that were clean, organized, and loaded with goods. "It was a dream come true," says Som.**

When asked why he became a U. S. citizen in 1989, **Som answered, "No one influenced me. It was a rough adjustment, but once we settled, there was no going back." He saw quality in the American government and lifestyle, and would have more opportunity and benefits.** He also wished to marry and have children. But his choice was not just about **benefits; it felt right in his heart. "I decided this is going to be my home, my future."**

Som now lives in Coalbrook with his wife, Bong, and their three sons: Shane (18), Jesse (16), and Grant (11), and their cat, Muffin.
